ORGANIZATION AND PROGRAM

Sierra Health Foundation: Center for Health Program Management (The Center) was founded by Sierra Health Foundation in 2012 as an independent 501(c)(3) nonprofit organization. With offices in Sacramento and Fresno, The Center pursues the promise of health and racial equity in communities across California. Leveraging leadership, operational and funding support from Sierra Health Foundation and its partners, The Center establishes investment partnerships with public and private funders; community members; community organizations; national, state and local government agencies; nonprofits; and businesses to advance health equity.

The California Funders for Boys and Men of Color (CFBMoC), co-founded by Sierra Health Foundation and managed by The Center brings together CEOs from the state's leading philanthropic institutions to shape a better future for boys and men of color—and for California. CFBMoC aligns the resources, networks and voices of California's private, family and community foundations with the goal of improving opportunities for multi-generational boys and men of color.

FUNDING OPPORTUNITY AND BACKGROUND

CFBMoC will award a total of \$300,000 in grants. Each grant is up to \$25,000 over 12 months for a qualifying nonprofit organization that serves people living in CFBMoC's 10-county Sacramento-San Joaquin Valley funding region (see map on page 3). These grants will support the development of a five-year regional education system blueprint to increase the number of boys and men of color pursuing and completing a post-secondary degree or career technical certificate program by 2030. The CFBMoC Sacramento-San Joaquin Valley Regional Action Committee (SSJV RAC) is made up of member foundations Sierra Health Foundation, Sacramento Region Community Foundation, The California Wellness Foundation, Stuart Foundation, NextGen Policy, ECMC Foundation, Sobrato Philanthropies and The California Endowment.



To improve educational outcomes of boys and men of color in Sacramento, San Joaquin, Stanislaus, Mariposa, Merced, Madera, Fresno, Kings, Tulare and Kern counties, CFBMoC will invest in key grassroots and advocacy organizations to support deeper engagement and policy, and systems change that will improve access to and completion of post-secondary degrees and certificate programs. CFBMoC will also invest in comprehensive training and technical assistance for the cohort of funded organizations, which will inform how to strengthen emerging solutions to address some of California's most pressing educational barriers for boys and men of color.

Improving Education-to-Economic Opportunity Pathways for Boys and Men of Color

California's leading global economy is fueled by multi-billion-dollar industry sectors that generate a variety of career, education and training pathways. CFBMoC is tracking K-12th grade indicators that prepare students across California to access and complete post-secondary education opportunities that lead to family-sustaining income at 300% of the federal poverty level.

In 2020, eight-in-ten (80%) high school boys in California graduated. However, Black and Indigenous boys are most often failed by school systems and have lower graduation rates than

white and Asian students. Students of color are five times more likely than white students to attend a high-poverty school in California, due to underinvestment in public schools serving students of color—including early education. Statewide, less than half (47%) of high school boys of color graduate high school meeting the entry requirements for the University of California and California State University systems¹. Racism and economic disadvantages, along with punitive school cultures, have rendered boys and men of color far less likely to complete post-secondary education programs than their white peers.

This funding opportunity reinforces the urgency to improve educational outcomes for boys and men of color while aligning strategies to reduce and prevent involvement with the justice system, including youth incarceration. Juvenile incarceration threatens school completion and increases the likelihood of going to prison from one in ten to one in three. In counties like Fresno, San Joaquin, Kern, Merced and Kings, youth incarceration rates can range from 15% to 100% above the state average.

Place-based Strategy and Program Grants

The CFBMoC launched a place-based strategy in 2016 designed to 1) align, amplify and accelerate existing successful models for system and policy change rooted in community; and 2) influence the allocation of public resources and attention in ways that would have the most meaningful impact. Together with policymakers, business and community leaders, we are working to build momentum, public will and policy attention so that California's boys and men of color:

- Are prepared for and thrive in school
- Reach math and reading milestones at the appropriate grade levels
- Earn their high school diplomas
- Graduate from college with quality degrees, credentials and certifications
- Face fewer arrests, convictions and recidivism as youth and adults
- Are healthy, safe and free from violence
- Secure meaningful and stable careers with sufficient pay to support their families

The strategy is based on a shared understanding that existing local and statewide efforts—community, public and philanthropic—must have a sharper analysis of the issues facing boys and young men of color to achieve population-level impacts. Guided by the CFBMoC North Star

Goal² and the Life Course Framework³, CFBMoC seeks to support and partner with regional leaders to transform policies, systems and institutions through its place-based strategy, via a combination of four priorities:

- **Priority 1:** Address school climate, communications, mental well-being and accountability.
- **Priority 2:** Strengthen pipelines from K-12 school districts and county office of education-run schools to community college and/or four-year university for justice-involved and/or system impacted boys and men of color.
- **Priority 3:** Organize power-building efforts and awareness of the fiscal and policy landscape at the city, county, state and/or federal level to identify opportunities to leverage governmental resources that could improve outcomes for BMoC.
- Priority 4: Align County Offices of Education programs and schools inside and outside
 juvenile detention facilities, community colleges and four-year universities that offer
 justice-involved students' opportunities and services in detention facilities and on
 campus.

To support these priorities and the blueprint development process, a cohort of funded partners will participate in strategy sessions throughout Sacramento-San Joaquin Valley and engage with the designated training and technical assistance provider. The training and technical assistance provider will take the collective feedback and develop a summarized blueprint outlining evidence-based practices to leverage and areas CFBMoC should consider funding. The CFBMoC Sacramento-San Joaquin Valley Regional Action Committee will make technical assistance available in the following areas:

- Data support
- Participatory action research
- Facilitation to complete the local and regional blueprints

ELIGIBILITY CRITERIA

This funding opportunity is open to nonprofit organizations that are tax-exempt under Section 501(c) (3) of the Internal Revenue Code and working in the CFBMoC Sacramento-San Joaquin Valley funding region. Fiscal sponsors for entities not qualifying 501(c) (3) nonprofits are eligible to apply if the project meets the criteria.

The most competitive applications will:

- Capitalize on existing, strong community leadership and infrastructure focused on building alliances and coalitions that help advance policy and system change campaigns aimed at improving the educational climates of local K-12 and Higher Education institutions where boys and men of color attend in Sacramento and/or San Joaquin counties.
- Leverage existing boys and men of color-related investments made by CFBMoC members—particularly those focused on dismantling the school-to-prison pipeline, addressing school climate and uplifting opportunities for English Learners.
- Leverage public and private leadership to focus attention on boys and men of color policy issues, such as the Alliance for Boys and Men of Color, California Alliance for Youth and Community Justice, Assembly Select Committee on the Status of Boys and Men of Color, My Brother's Keeper cities, etc.
- Demonstrate work that explicitly supports health and racial equity and operates across intersecting issues to improve educational outcomes for boys and men of color.

Scope of Work

Funds from this grant will be used by a cohort of partners to develop a collaborative blueprint and workplan that facilitates preparation, access to, and completion of post-secondary associates-to-transfer degree programs, high value career-technical certificate programs or bachelor's degree programs. Grantees are expected to fully participate and collaborate inperson in four to-be-determined counties throughout the funded region. Cohort meetings will convene fellow grantees, systems leaders and youth across the region to develop a collective education regional blueprint for boys and men of color.
